The following is a list of 466 gifts in the first quarter of 2007. All were announced in various newsletters, newspapers, press releases, or other publications. None are verbal reports. A tabulation of this type was estimated by the late Arthur C. Frantzreb, founder of the Million Dollar List, to be one-fourth to one-half of those gifts actually consummated during the quarter because gifts to health care, religious organizations, cultural institutions, social service agencies, and other organizations are not reported in a systematic way.

In the tables below, gifts contributed through personal or family foundations are considered foundation gifts/grants, not individual gifts. Foundation and corporate gifts are reported in a separate table and in the Total Gifts and Grants table.
